
# **1.5 A, Adjustable Output, Negative Voltage Regulator**

The LM337 is an adjustable 3-terminal negative voltage regulator capable of supplying in excess of 1.5 A over an output voltage range of -1.2 V to -37 V. This voltage regulator is exceptionally easy to use and requires only two external resistors to set the output voltage. Further, it employs internal current limiting, thermal shutdown and safe area compensation, making it essentially blow-out proof.

The LM337 serves a wide variety of applications including local, on card regulation. This device can also be used to make a programmable output regulator, or by connecting a fixed resistor between the adjustment and output, the LM337 can be used as a precision current regulator.






5. Power dissipation within an IC voltage regulator produces a temperature gradient on the die, affecting individual IC components on the die. These effects can be minimized by proper integrated circuit design and layout techniques. Thermal Regulation is the effect of these temperature gradients on the output voltage and is expressed in percentage of output change per watt of power change in a specified time.


6. Since Long Term Stability cannot be measured on each device before shipment, this specification is an engineering estimate of average stability from lot to lot.

This device contains 39 active transistors.








Figure 2. Load Regulation and  ${\bigtriangleup I}_{\text{Adj}}\text{/Load}$  Test Circuit




Figure 3. Standard Test Circuit





Figure 4. Ripple Rejection Test Circuit






Figure 11. Ripple Rejection versus Output Voltage

Figure 12. Ripple Rejection versus Output Current




Figure 13. Ripple Rejection versus Frequency

Figure 14. Output Impedance




Figure 15. Line Transient Response

## APPLICATIONS INFORMATION

#### **Basic Circuit Operation**


The LM337 is a 3-terminal floating regulator. In operation, the LM337 develops and maintains a nominal -1.25 V reference (V<sub>ref</sub>) between its output and adjustment terminals. This reference voltage is converted to a programming current (IPROG) by R1 (see Figure 17), and this constant current flows through R<sub>2</sub> from ground.

The regulated output voltage is given by:

$$V_{out} = V_{ref} \left( 1 + \frac{R_2}{R_1} \right) + I_{Adj} R_2$$

Since the current into the adjustment terminal  $(I_{Adj})$ represents an error term in the equation, the LM337 was designed to control  $I_{Adi}$  to less than 100  $\mu A$  and keep it constant. To do this, all quiescent operating current is returned to the output terminal. This imposes the requirement for a minimum load current. If the load current is less than this minimum, the output voltage will rise.

Since the LM337 is a floating regulator, it is only the voltage differential across the circuit which is important to performance, and operation at high voltages with respect to ground is possible.

#### Load Regulation

The LM337 is capable of providing extremely good load regulation, but a few precautions are needed to obtain maximum performance. For best performance, the programming resistor  $(R_1)$  should be connected as close to the regulator as possible to minimize line drops which effectively appear in series with the reference, thereby

degrading regulation. The ground end of R2 can be returned near the load ground to provide remote ground sensing and improve load regulation.

#### External Capacitors

A 1.0 µF tantalum input bypass capacitor (Cin) is recommended to reduce the sensitivity to input line impedance.

The adjustment terminal may be bypassed to ground to improve ripple rejection. This capacitor (CAdi) prevents ripple from being amplified as the output voltage is increased. A 10 µF capacitor should improve ripple rejection about 15 dB at 120 Hz in a 10 V application.

An output capacitance ( $C_0$ ) in the form of a 1.0  $\mu$ F tantalum or 10 µF aluminum electrolytic capacitor is required for stability.

#### **Protection Diodes**

When external capacitors are used with any IC regulator it is sometimes necessary to add protection diodes to prevent the capacitors from discharging through low current points into the regulator.





Figure 18. Voltage Regulator with Protection Diodes

Figure 18 shows the LM337 with the recommended protection diodes for output voltages in excess of -25 V or high capacitance values ( $C_O > 25 \ \mu F$ ,  $C_{Adj} > 10 \ \mu F$ ). Diode D<sub>1</sub> prevents C<sub>O</sub> from discharging thru the IC during an input short circuit. Diode D<sub>2</sub> protects against capacitor CAdj discharging through the IC during an output short circuit. The combination of diodes D1 and D2 prevents CAdi from the discharging through the IC during an input short circuit.

Power Dissipation versus P.C.B. Copper Length


